\*\*Law School pass rate is how the Law School's graduates performed across all jurisdictions where they took the bar examination for the first time.

\*\*\*The ABA weighted average bar pass rate is the average pass rate for graduates from ABA-accredited law schools for each jurisdiction in which the Law School's graduates sat for the bar exam. This number is weighted so that bar pass rates from jurisdictions where more of the Law School's graduates sat for the bar exam have a greater impact on the ABA weighted average bar pass rate than bar pass rates from jurisdictions where fewer of the Law School's graduates sat for the bar exam.

\*\*\*\*The difference between the Law School pass rate and the ABA weighted average bar pass rate compares the performance of the Law School's graduates on the bar exam in all jurisdictions where they took the bar exam for the first time with the performance of graduates from all ABA-accredited law schools on the bar exam in those same jurisdictions. \*\*\*\*\* Starting with the 2025 Bar Admission Outcome report, graduates pursuing alternative pathways to bar licensure were no longer reported both in the category with graduates who did not take a bar exam and in the category of graduates admitted via alternative pathways. This change is reflected for 2024 graduates in the First-Time Bar Admission table, but does not impact the Total First-Time Bar Admission Rate.
